ACCESS TWO CYBER INVESTMENT INCENTIVE TAX CREDITS IN MD

Buy Maryland Cybersecurity Tax Credit. For Qualified Maryland Companies that purchase cyber technologies or services from a Qualified Maryland Cybersecurity Company (QMCC), Qualified Maryland Companies may claim a tax credit of up to \$50,000 per tax year.

Cybersecurity Investment Incentive Tax Credit (CIITC). Qualified investors can receive a credit equal to 33% of an eligible investment in a QMCC.
